Dear Residents, Families and Friends,

As we continue to follow all standards and precaution to ensure the safety of your loved ones, an area I wish to address is the transport of a resident in your personal vehicle to any appointment outside the “community.”

- Residents and visitors/individuals transporting a resident must sign an informed consent prior to the transport. That form is attached for your review.
- Visitors are required to undergo COVID-19 screening upon arrival.
- The resident is required to undergo COVID-19 screening prior to leaving the “community” and upon return from the outside appointment.
- Residents and visitors/individuals must wear either a surgical mask or an N95 mask at all times. If you do not have a mask, one will be provided for you upon arrival.
- Social distancing (minimum of 6 feet) must be maintained at all times.
- No physical contact between residents and individuals is permitted. This includes, but is not limited to, hugging, kissing, hand holding and all other forms of physical contact.
- Any resident who is suspected or confirmed to be infected with COVID-19 or is quarantined for an exposure to a COVID-19 case cannot be transported except for an end of life situation. A resident who has been diagnosed with COVID-19 may be transported in your vehicle only after they have met the criteria for discontinuation of isolation as defined in guidance from the NJ Department of Health and the CDC.
- Any visitor diagnosed with COVID-19, under investigation for COVID-19, with a temperature above 99 degrees Fahrenheit, with chills, cough, shortness of breath, difficulty breathing, sore throat, fatigue, muscle or body aches, headache, new loss of taste or smell, congestion or runny nose, nausea or vomiting, diarrhea, or who traveled from a designated COVID-19 “hot spot” within the past 14 days will not be permitted to transport the resident.
- We strongly urge you not to share food/drink during the transport. Visitor/Individual may bring items for the resident but must leave the package with reception. Visitors may bring their own drinks but may not share them with the resident. Hydration will be provided for the residents by the facility.
- Visitor/Individual will not be permitted into the building beyond the reception area and restrooms will not be available to visitors.

Following is the visitation process:

- Contact Karen Natkow at 732-568-1155, ext. 303 to schedule the pick up of the resident.
- When you arrive at the community, proceed into the lobby for screening, consent form and further instruction.
- If you arrive early, please wait in your vehicle until your appointment time.
- The resident will be brought to the reception area by a staff member at the appointed time.
- At the end of the visit, the resident will be transported back to his/her room by a staff member.
- After you transport the resident in your vehicle, it is recommended you clean any door handle, and all other areas/objects utilized during the transport with disinfecting wipes.

I understand that the rules governing transport of your loved one are restrictive. There are reasons for that - the health, safety and survival of your loved ones and each of you. If you have any questions in advance, please contact me directly. Otherwise, I look forward to seeing many of you soon.
